### COVID-19 MASK GUIDELINES & DATA UPDATE

The Barren River District Health Department has confirmed a total of 30,637 cases, 28,011 of which have recovered. We have 433 deaths reported from COVID-19. We stand in solidarity with those affected during these difficult times. See the breakdown of numbers by county below. Please note that a decrease in numbers is due to the county of residence or case status being corrected/updated from what was previously reported.

### Make Guidelines Update

Kentucky will follow the CDC's new mask guidelines for vaccinated people. Any person who has received the final dose of COVID-19 vaccine at least fourteen (14) days prior is not required to wear a face mask in any setting, except for in the following situations:

- Any person shall wear a face mask when riding on all planes, buses, trains, and other forms of public transportation traveling into, within, or out of the United States and in U.S. transportation hubs such as airports and stations.
- Any person in a K-12 educational, preschool, daycare, or other childcare setting, including any student, employee, staff member or visitor shall wear a face mask.
- Any person in a healthcare setting shall wear a face mask.
- Any person in a long-term care setting shall wear a face mask.
- Any person in a correctional facility should wear a face mask.
- Any person in a homeless shelter should wear a face mask.
- Any person who is immune-compromised, or who is exhibiting symptoms of COVID-19, or who has tested positive for COVID-19 in the prior ten (10) days should wear a face mask.

- Available timeslots will be listed, click Load More to show ALL available timeslots for that day.
- After clicking the timeslot you want, on the appointment details screen click "Book Now".
- You will be prompted to enter an email address or sign in...enter an email address. If you do not have an email address, please call us for assistance.
- Enter first and last name, then enter a password and click Submit.
- Next, enter your cell phone number and click Submit. You will receive a passcode on your cell phone, enter that passcode on the website and click Submit.
- Finally, click Confirm Booking and you are all set!
